Thursday, May 16th, 8:30 AM - 12:00 PM – U.S. Section Presentations

Third-party challenges (pre- and post-grant) in the USPTO in the new post-AIA world

Short Description: This session will address how the patent system has changed to allow third parties to invalidate granted patents and to attempt to prevent the grant of patent rights. In addition to the changes in the rules, strategies relating to such third-party challenges and whether or not to even challenge in the first place will be discussed.

EU Patent Reform

Short Description: This presentation will provide an update on the progress of EU Patent Reform, explain what will happen next, and address some of the key issues. FICPI-UK has been represented at the European Reform Group meetings held by the UK IPO, and this has provided invaluable insight into the European legislation process and the next steps to be taken on the long road to a Unitary patent.

EPO Oppositions

Short Description: This session will address EPO Oppositions and compare them with the proposed EU court procedures. The proposed European Patent Court will be a new court with new rules, much like the EPO when it opened its doors. This presentation will examine how EPO Oppositions currently work and what lessons can be learned for the new proposed court.

Using the UK national route

Short Description: This presentation will explain the advantages and disadvantages of using the UK national route, given its potential use as a “shelter” from the unitary patent provisions. With a number of changes to the UK patent system (e.g., patent box and improved Bolar provisions) and the “customer-friendly” outlook of the UKIPO, it is likely that more will use this alternative in future.

Erosion of the cornerstones of the CTM system

Short Description: This session will review some issues that seem to be eroding the basis of the CTM system, such as changes to the practice on specifications and the requirement for use being met by use in a single member state. If the EU Commission has finally released its proposals for revision of the CTM regulation, then these will also be reviewed. These proposals have been long-awaited and much delayed, but could significantly alter the TM landscape in Europe.

Designs – Reform in the UK and recent EU Cases

Short Description: This presentation will explain the UK’s proposal to amend national design law, as well as some recent important decisions, including *Apple v. Samsung*. With the Community Design System having been in place for ten years, some of the questions posed by the legislation have been answered by the Office and Courts. Despite there being a harmonised registered design law in Europe, this harmonisation doesn’t extend to unregistered design regime, where it is expected the UK will propose changes.
