St. Petersburg, Peter the Great's "Window to the West", is undoubtedly one of the most stunningly beautiful cities in the world.



There could be whole countries who probably can't boast as many great sights as this single city. From the priceless treasures of the world-famous Hermitage to the palaces and art of the Russian Museum, there's a lot of culture to be enjoyed in St Petersburg! Its World-Heritage-Listed city centre, designed by the greatest European architects, is one of the most awe-inspiring in Europe.

In addition, from a historical point of view, Catherine the Great, Peter the Great and the last Russian Tsars all left their mark here, as did famous Russian writers such as Dostoevsky and Pushkin.



Peter the Great, founder of St. Petersburg, moved his court from Moscow to the planned new settlement in 1703 and St. Petersburg was quickly hailed as a victory of man over nature as more than 40 islands were joined together by drawbridges at the delta of the Neva River; this is the reason why St. Petersburg is also known as the "Venice of the North". This charming city, which is more than 3 centuries old, has always managed to preserve its glory and beauty despite neglect during the Soviet period and the terrible siege during World War II.

St. Petersburg is also the right place to go to if you simply want to enjoy yourself and have fun! Its lively nightlife scene is renowned and the locals are reputed for being much more relaxed than in Russia's capital, Moscow. Every season has its own special celebrations and fine dining, world-class ballets, opera and cafe culture are all part of the St. Petersburg way of life.



CLIMATE: As a maritime city, St. Petersburg is never really cold - at least not by Russian standards - but there is high humidity throughout the year: so whether you visit in winter or summer, waterproof clothing is essential. Autumns are short, and generally the weather remains comparatively mild until mid-October, when temperatures begin to dip below freezing. The average temperature in October is 6°C/43°F.

SCHEDULE OF EVENTS

The **16th Open Forum** programme will begin on Wednesday, 5 October with the welcome reception at the New Stage of the Alexandrinsky Theatre, where Forum delegates and guests will have the chance to enjoy a ballet performance and a cocktail reception.

The Forum will continue with business meetings on Thursday and Friday. A plenary session will be followed by the usual “three streams” format, intermingled with a break out workshop dealing with a specialised patent topic.

The Forum closing dinner on Friday, 7 October, will take place in the Russian Museum of Ethnography.

On Wednesday, 5 October, optional guided tours have been organised both in the morning and in the afternoon.

Tours for the Delegates’ Guests’ (DGs) are included on Thursday and Friday, 6 and 7 October. Optional excursions are also scheduled on Saturday, 8 October.

VENUE & ACCOMMODATION

Airport

St. Petersburg's new international airport Pulkovo (Terminal 1, open since December 2013) is located about 20 kilometres south of the city centre (metro Moskovskaya).

It is the third busiest airport in Russia, serving about 160 domestic and international destinations, with a capacity of almost 17 million passengers per year.

To reach the city centre from the airport, one can take bus number 39 or mini-bus (marshrutka) number K39 to Moskovskaya metro station (seven stops – the journey usually takes 15-25 minutes, depending on traffic) and then take the metro into town. Metro signs are displayed in Russian and English.

If you choose to take a taxi, we recommend using the official Pulkovo airport taxi company from their desk inside the airport: [TAXI 6000000](tel:+78126000000) Tel. +78 12 6000000 www.6-000-000.ru

The average price for a trip from the airport to the Corinthia Hotel will be about RUB 1.150 (approximately €15 at the time of publishing this document). Please be aware that the charge will be in RUB and that most taxi drivers do not speak English.

ENIC meetings & events can arrange for private transfers; please refer to the registration form for the relevant information.

Taxis

Taxis in St. Petersburg are relatively cheap but, in order to avoid being overcharged, before climbing aboard, always agree on the fare with the driver!

If you book a taxi by phone with a legitimate taxi company, you will be quoted an exact price for the journey. Unfortunately, not all of the companies have English-speaking operators, but one can book a taxi online with many of the major taxi companies.

FICPI Events Transportation

Transportation for the DGs' tours and the optional excursions, as well as for the social events (except for the welcome reception, for which transfer will be on foot) will be by bus, and will be available **exclusively for those who make arrangements with our organisers at the hotels pre-booked for FICPI**. Session 8	<p>The introduction of the Unitary Patent and Unified Patent Court seem (finally) to be almost upon us. In December 2015, the EPO’s Select Committee finalised the required legal instruments for the Unitary Patent; the Preparatory Committee aims to conclude its work on the Rules of Procedure for the Court by mid-2016. Subject to the necessary ratifications, the UPC could be launched very soon. It will have an immediate and profound effect on the patent landscape in Europe. Practitioners must know what to advise their clients on the new opportunities and risks the new unitary patent regime will bring; they cannot afford to be left behind. DGS' GUIDED TOUR "IN THE HEART OF ST. PETERSBURG"

The early private opening of the Church of Saviour on the Spilled Blood will start with a special performance of the Kids' Choir of Radio and Television, the first Kids' Choir to be founded in the USSR, in 1955. This imperious church, known for its onion-shaped domes, hosts one of the largest mosaic collections in the world. It was founded to commemorate Tsar Alexander II on the exact site where he was killed in 1881.

The visit of the gorgeous Resurrection church will be followed by the guided visit of the oldest and most historical building in St. Petersburg, the Peter and Paul Fortress. This complex is a unique sample of Russian 18th-century architecture; built as a fortification, it served for almost two centuries as a burial-place for Russian emperors including Peter the Great and Tsar Nicholas II and his family, murdered in 1917.

After lunch, we will make a stop to allow our guests some free time for shopping at the Elisseeff Emporium: not only a food hall, but also one of most striking examples of St. Petersburg Art Nouveau architecture.

CLOSING DINNER

The Russian Museum of Ethnography, representing the cultural peculiarity of the different nationalities of the Russian Federation, is one of the largest museums of this kind in the world. Two optional full-day excursions (A and B) are available on Saturday, 8 October: one in the city (visiting the Yusupov Palace and St. Isaac's Cathedral) which is more suitable for those who will leave St. Petersburg in the afternoon, and the other to Tsarskoe Selo, the Tsar's Village in Pushkin (visiting Catherine's Palace and Park).

The Saturday excursions will afford delegates and their guests a further excellent opportunity for networking or relaxed socialising with other delegates and old friends to discuss matters of mutual interest.

OPTION A - ST. PETERSBURG: YUSUPOV PALACE AND ST. ISAAC'S CATHEDRAL

The exclusive early opening of the Yusupov Palace, which once belonged to the rich and powerful Yusupov family, will provide FICPI guests with the chance to admire one of the city's most beautiful Classicism style buildings. The palace interiors are richly decorated and host a valuable collection of paintings, sculptures and items of applied art. The Yusupov Palace is also famous for the murder of Grigory Rasputin, in December 1916, by Prince Yusupov. Rasputin, who held a crucial role in the fall of the Russian Empire, is one of the most controversial and mysterious figures of Russian history.

We will then make a stop in front of the Mariinsky theatre, the premier opera and ballet house of Russia, and one of the most famous theatres in the world. Our tour will continue with the visit of St. Isaac's Cathedral, a gorgeous late-Neoclassical monument built in 1818-1858 by the French-born architect Auguste Montferrand, which has become one of the most impressive landmarks of the Russian Imperial capital. One hundred and eighty years later, the gilded dome of St. Isaac's still dominates the skyline of St. Petersburg. Lunch is included.

In this imperial estate there are actually two vast and truly exceptional palaces (Catherine and Alexander), both surrounded by extensive landscaped gardens with diverse and fascinating decorative architecture.

We will have lunch in the authentic restaurant "Podvorje", built as a traditional Russian wooden *terem* (mansion). Its atmosphere of a rural house, with authentic furniture, folklore musical entertainment, the attire of the staff and traditional Russian dishes transmit the unique spirit of a XVII-XIX century Russian village.

VISAS

The majority of non-Russian citizens wishing to enter the Russian Federation must bear a valid Russian visa, although there are some exceptions, e.g. citizens of countries which have signed a bilateral visa-free regime agreement with the Russian Federation cf. <http://tinyurl.com/h2dvw6g>

A tourist visa, providing a single entry/exit visa valid for the specified duration of your stay in Russia, maximum 30 days, is the easiest and cheapest type of visa to obtain, and we strongly suggest to apply for this. However, if you plan to stay longer in Russia, or will need to enter Russia more than once during your trip, you will require a business visa.

For your information, cruise and ferry passengers may remain on the territory of St. Petersburg up to 72 hours without a visa, if such passengers arrive in the city as part of a tourist group aboard a ship.

In order to obtain your tourist visa, you will need to take the following actions:

1. Make your registration & hotel reservation for the FICPI 16th Open Forum.
2. Ensure your passport is valid for the dates you are planning to travel: most consular departments will require that it is valid for at least six months after your planned departure date from Russia.
3. The hotels pre-booked for FICPI will act as “visa sponsors” and within a few days of making your registration will supply to you – through our Conference organizers ENIC meetings & events - the visa support documents (hotel voucher and confirmation in Russian), as required by Russian consular departments to process your tourist visa application. These documents can be presented to most Russian consular departments as faxed copies. Please check with your nearest consular department or visa centre to ensure whether a copy would be acceptable or whether originals will be required.
4. Most Russian consular departments will require you to obtain health insurance valid in Russia, covering the dates of your proposed trip. Often, Travel Agencies or even

Russian consular departments can provide this. Your visa application must also be accompanied by a recent photo.

5. In order to obtain the visa you will also need to submit, along with your passport, visa support documents, health insurance and photo, a completed Visa Application Form (available online at <http://visa.kdmid.ru>); these documents should be submitted to your nearest Russian consular department or visa centre.

When entering the Russian Federation, a migration card (in English and Russian) will be given to you. If you arrive at St. Petersburg Pulkovo airport (or another major Russian airport), the migration card will be printed automatically and handed to you at passport control and you must keep it with your visa and your passport until your departure from Russia.

On arrival in the Russian Federation, a foreign citizen must register according to his/her address of temporary stay. The conference hotels will carry out this registration procedure for you upon your check-in (a small registration fee amounting to approximately €4 to €5 per stay will be applied for this).

Please note that in case of cancellation of your reservation, the hotel which will have provided you with the visa documents will charge you with a visa cancellation fee, which will be respectively: €60 for the Corinthia Hotel and €40 for the Radisson Hotel.


